This is in response to your November 10, 2016, request for a copy of the application for tax-exempt status and the determination letter for Southwestern Medical Foundation.

All applications and related documents filed prior to January 1, 1948, have been destroyed pursuant to Congressional authority and therefore are not available for inspection. While we were unable to provide copies of these documents, our records indicate a determination letter was issued in May 1940, recognizing the organization as exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code.

Our records also indicate this organization is not a private foundation within the meaning of section 509(a) of the Code because you are described in section(s) 509(a)(1) and 170(b)(1)(A)(vi).
