ormer UT Southwestern anesthesiology residents have raised \$100,000 to establish the Anesthesiology Alumni Professorship. An additional \$20,000 donated to the fundraising effort will be used to enhance the two libraries of the Department of Anesthesiology and Pain Management.

More than 700 former residents made contributions to Southwestern Medical Foundation, which earmarked their gifts for the professorship.

The drive was spearheaded by Dr. M.T. Pepper Jenkins, who was chairman of anesthesiology for 33 years.

"The response to Dr. Jenkins' solicitation of former residents in the area of anesthesiology was truly remarkable and a wonderful tribute to him," said Dr. Charles C. Sprague, chairman of the board and president of the Foundation. "There are few who could simply write a letter and get this type of response."

Dr. Jenkins said, "As I approach final retirement after 46 years, I want the department to achieve a new dimension by recognizing and honoring in perpetuity all of our past and present residents and teaching staff."

The successful campaign is a testament to Dr. Jenkins, said UT Southwestern President Dr. Kern Wildenthal.

"I am sure this came to be because of the respect and admiration all of our anesthesiology residents have for Pepper Jenkins," Dr. Wildenthal said. "It is a tribute to him as well as the alumni."

Dr. Edward R. Johnson, acting chairman of anesthesiology and pain management, has been named holder of the professorship.

"Dr. Johnson is held in great respect by the residents for the depth of his knowledge and his abilities to impart it, for his fairness in managing the difficult Parkland Memorial Hospital main operating-room schedule and for his superior ability at keeping peace and harmony in the department despite chaotic clinical requirements," said Dr. Jenkins.

The Department of Anesthesiology and Pain Management maintains a library and study area named the Jenkins Anesthesiology Library of Dallas in its office suite at Parkland Memorial Hospital. A second library, located in the Charles Cameron Sprague Clinical Science Building, is named the Giesecke Anesthesiology Library in honor of Dr. A.H. Giesecke Jr., another former chairman.

Mr. Hay has been active in national politics for more than 40 years. In 1977 and 1978 he was national finance chairman of the Democratic National Committee. He also has held important positions in a number of senate and gubernatorial campaigns in Texas as well as in several presidential campaigns.

He is on the boards of Exxon Corp., Southwestern Bell Corp., the Dial Corp., Trinity Industries, Lomas Financial Corp. and the State Fair of Texas.

Mr. Hay has been responsible for establishing two endowed chairs at UT Southwestern. In 1983, he established the Betty Jo Hay Distinguished Chair in Mental Health in honor of his wife. And in 1993, Mr. Hay's company, Lomas Mortgage USA, created the James M. Wooten Chair in Cardiology in honor of the former president of Lomas & Nettleton Co.

Donald Zale is one of the founders of Zale Lipshy University Hospital and has served as chairman of its board of directors since 1987.

Mr. Zale serves on the Executive and Finance committees of Southwestern Medical Foundation and was chairman of the Finance Committee for several years. He is also a current member of the

Children's Medical Center Foundation board of directors.

Mr. Zale is chairman of the board of the Zale Foundation, chairman of Capitol Entertainment and president of NewCourse Capital, a private investment firm he established after leaving Zale Corp. His tenure at Zale lasted 35 years and culminated in his serving as chairman and chief executive officer. He is a 1954 graduate of Southern Methodist University.
